II GENERAL DOCUMENTS

- accurately filled and rated application for a scholarship;
- certificate of regular enrollment in academic 2015/16 year;

- a written statement that the applicant is not, and shall not be, a scholar of the second legal entity or an individual and shall not exercise the right to financial compensation on other basis in ac. 2015/16 year if he/she exercises the right to the Fund "Bošnjaci" scholarship (*statement given and certified by a municipality*);
- a written statement by which the candidate consents that, during the publication of the ranking list or results of the competition, the Fund "Bošnjaci" can reveal personal data on the Fund's web site (*statement given and certified by a municipality*).

III DOKUMENTS REQUIRED FOR RATING

- certificate of having passed the exams from previous years with an **grade point average calculated** to two decimal places;
- for students of the first year of study – certified diploma and certificate of the final grade of the high school and a prove that an applicant or student is either a pride or a student of the generation;
- evidence for winning first, second or third place at cantonal, entity, national or international competition in mathematics, physics, information science and foreign languages for the previous academic/school year or via the relevant ministry of education;
- diploma of Riyasat of Islamic Community in Bosnia and Herzegovina of passed Hifz;
- evidence of total monthly revenue/income of all adult household members on the basis of: employment, pension, self-employment, war veterans protection and other sources (**pay slip** indicating actual earnings for the last month is required for employed household members, for pensioners last pension check, IMO and LIMO checks, assurance of Employment service for unemployed household members, and if they are not registered in Employment service they will provide assurance from PIO/MIO office that is not registered as insured person from employment or a certified copy of the health insurance booklet from which one can see information about the insured person, insurance basis or relationship with insured person, for household members under the age of six years a birth certificate is required)
- a certificate that no one of adult household members do not posses own business (issued by the Tax Administration office or any other authorized entity from which will be clear whether they are registered or not registered in a registry of taxpayers as entrepreneurs or that they are registered or not registered in the uniform system for registration, control and collection of contributions as taxpayers on any basis with reported monthly and annual incomes;
- evidence for parents: shahid family, without one or both parents (extract from the register of deaths), evidence for participation in the liberation war during aggression on RBiH for at least 24 months, evidence for wartime disability of parents – over 60 or 80%;
- evidence for personal disability of the candidate - over 60%;
- for pupils and students from the household is required an assurance for regular school or faculty enrolment.

Original documents or certified copies should be submitted together with application for the scholarship and they must be marked in the boxes in the following way
